# Florence LEGROS Appointed Executive Delegate of the Artem-Nancy Association

Florence LEGROS, General Director of ICN Business School, was appointed Executive Delegate of the Artem Alliance during the most recent Board of Directors meeting by Christophe CHOSEROT, Vice President of the Greater Nancy Metropolis in charge of higher education, research, and innovation, and re-elected President of the Association at the General Assembly held on November 27. According to the statutes, this mission is alternately assigned for a renewable two-year term to one of the directors of the three founding schools of the Artem Alliance. Florence LEGROS succeeds Christelle KIRCHSTETTER, Director of the École Nationale Supérieure d'Art et de Design de Nancy, who held this position since 2020.



Through this appointment, Florence LEGROS returns to a role she previously held from May 2016 to June 2018. Her first term was marked by the gathering of the three schools on the Artem campus, inaugurated in 2017.

It is worth noting that Artem will celebrate its 25th anniversary in 2025, an occasion that will be marked by events on the campus.

Florence LEGROS has been the General Director of ICN Business School since September 2015. Holding a PhD in Economic Sciences and an Aggregated Professor of Universities, she began her career as an economist at the Caisse des Dépôts et Consignations in 1987, then at the Direction of Pensions where she was responsible for the financial management of pension funds (notably CNRACL and Ircantec) and affiliated pension plans from 1992 to 2000, after serving as Research Director at Dexia Bank from 1990 to 1992.

She was a professor at the University of Perpignan from 1994 to 1997 and at the University of Paris Sud from 1997 to 1999 before joining Paris Dauphine University in 1999, where she remains a professor and where she founded the Dauphine School of Insurance.

Florence LEGROS subsequently served as Deputy Director of CEPII (Centre d'Études Prospectives et d'Informations Internationales) from 2000 to 2003, Vice President of CIREM (Information and Reflection Club on the Global Economy), and Deputy Director of the European AIM (Adequation of Pensions) program from 2003 to 2008.

From 2008 to 2011, she was Rector of the Dijon Academy, Chancellor of the University of Burgundy, and a university professor at Paris-Dauphine from 1999 to 2015, while also serving as Director of the Dauphine School of Insurance.

An expert on pension systems, savings, and financial markets, and author of numerous publications on these topics, Florence LEGROS served on the Pensions Advisory Council from 2000 to 2004 and on the National Economic Commission from 2007 to 2014.

She was also a board member of AERES (Agency for the Evaluation of Research and Higher Education) / Hcéres (High Council for the Evaluation of Research and Higher Education) and Senior Research Fellow at CEPS (Centre for European Policy Studies in Brussels). She also acts as an expert on pensions and savings for international organizations and French companies.

Florence LEGROS has been decorated with the Legion of Honor, the National Order of Merit, and the Palmes Académiques.
