# **ACCESS TIME**

- A relevant research proposal whose value can be demonstrated (particularly in terms of its potential impact on management practice).
- A good level written and spoken English is required for the programme. Applicants' English language skills will be assessed at the admissions interview (no formal test is required).

# ASSESSMENT METHODS

Evaluation of the thesis after 4 years.

Each module is subject to an overall assessment based on the research submitted by the doctoral students and their presentations during the seminars. The thesis is assessed based on the preliminary reports and the defence.

# CONDITIONS FOR SUCCESSFUL COMPLETION AND AWARD OF THE DIPLOMA

Validation of the thesis.

After successful defence of the thesis, graduates will receive both a university degree of Doctor in Business Administration from Manchester Metropolitan University (MMU) and the title of Executive Doctor in Business Administration from ICN & the Business Science Institute.

Students also receive a Certificate of Research in Business Administration after completing  $Stage \ 1$  of the programme.

# **TUITION FEES**

- Title of Executive Doctor in Business Administration from ICN & the Business Science Institute – for 3 to 4 years - € 30.000
- Titles of Executive Doctor in Business Administration from ICN & the Business Science Institute + university degree of Doctor in Business Administration from Manchester Metropolitan University (MMU) – for 3 to 4 years - €37.500

# **OBJECTIVES**

# Training objectives

Carrying out an impactful piece of research with a thesis that the experience of the doctoral candidate-manager, academic hindsight and managerial recommendations.

#### Operational objectives

The Executive DBA is spread over three phases, organised to enable participants to defend their thesis within 4 years.

The first phase of the programme is devoted to :

- Fundamental seminars to acquire knowledge and methodologies needed to conduct research,
- Defining the subject of your thesis, based on your preferences, during seminars and discussions with your professors,
- Identification of the thesis supervisor.

The second phase is devoted to data collection and the tutored writing of the thesis, under the supervision of a professor from the Scientific Advisory Board or thesis director. A three-day Impact seminar and three one-day follow-up seminars are organised. At each research follow-up seminar, the doctoral student manager presents the elements of his or her research project in a few slides: in the 15 to 20 minutes allotted, he or she focuses on :

- The diary,
- Advancement,
- The questions.

The third phase is devoted to writing the thesis and defending it publicly before a panel of professors. The doctoral student-manager will also attend two follow-up seminars.

The actual duration of Executive DBA thesis will depend on the doctoral student:

- Its availability,
- His ability to research, work and write.

Each module is subject to an overall assessment based on the research submitted by the doctoral students and their presentations during the seminars. The thesis is assessed on the basis of preliminary reports and the defence.
