OBJECTIF

Objectif of the programme

Operational objectives

TERMS OF ENTRY

To be eligible for programme students must have either:

- A Master's degree or an equivalent degree appropriate to the programme.
- Research or professional experience at the postgraduate level and published research work or written reports or be able to provide other appropriate evidence of achievement.

ACCESS TIME

Students download their applications online. This application includes:

- A CV
- A Research Proposal
- A statement of Motivation for completing a PhD
- Two Academic Reference

After careful examination of the application, an interview is organized to validate the quality of the candidate's file.

EVALUATION METHODS

Assessment through continuous assessments at the end of each module.

CONDITIONS FOR PASSING AND AWARDING THE DIPLOMA

Students must validate all their modules, and successfully defend their thesis.

TUITION FEES

Tuition fees are waived for all students whose year-to-year progress is confirmed by the PhD Board. Tuition fees are waived for a maximum of four years. Any additional year will be subject to a fee of €9,000.

JOB PROSPECTS

After their PhD students could:

- Join a prestigious business school or university and embark on a career in research & teaching.
- pursue a career in internationally operating companies.
- become a management consultant.


